## News from the Chair

## Shirt/Uniform Vote

The club recently emailed members to vote for a change to our uniform or not for 2024. If our uniform was to change, there was a choice of 4 designs to choose from for shirts/tops and that the bottoms ie pants/skirts would be Royal Blue for both men and ladies. The results of this vote was as follows: -
Only 56 votes were received hence the committee have assumed that the members who did not vote are not concerned with the outcome.
Within the 56 votes, 41 of these chose to change our shirts/tops to design number 1. This outcome was discussed at our June committee meeting and was agreed to commence the process of changing our uniform. Both the Men's and Ladies committees have been sent a letter to advise of our intension to change the club's uniform commencing in 2024. This does not mean that all members must purchase a new uniform immediately, however those members that play competition for our club will need to update their uniform for 2024. The current uniform can still be worn for internal club fixtures.
The club will need to make application to both CQDMBA/CQDLBA and Bowls Queensland to ratify and register our new uniform.

## Grants

Our club has just received a grant for $\$ 2,500$ to which the committee has yet to decide how it will be expended under the criteria of our appointment.
The outcome of our grant application to bitumen our car park will not be known until the end of June or early July, fingers crossed for a favourable outcome.

## Functions

We have 6 functions booked for June and 2 functions booked for July to date. Bookings for Xmas parties have commenced in earnest for November and December. As a reminder our club Xmas party will be held on Friday 15th December, the Caterer and the Musician have been booked.

## Bowls Rule of the Month

## Law 37.1 Deliberate Bowl Displacements (World Bowls) Introduced from 1st April 2023

There has been lots of discussion on the new laws of having to forfeit a game, in light of this confusion World Bowls have decided to rescind the following laws effective immediately.

World Bowls Laws Advisory Group decision on Laws 37.1.3 and 37.1.5.3

In August 2022 the above two new laws were introduced to the Laws of the Sport Crystal Mark Fourth Edition. They were designed to penalise a player who deliberately displaced their own teams bowl on its original course or lifted a bowl at rest to allow one of their own team's bowls to pass.

Despite a clarification document published on the World Bowls Website in September 2022, it has become very clear from communications that the two laws have caused a great deal of confusion and have resulted in games being forfeited incorrectly following players innocently stopping bowls from entering the ditch.

Furthermore, the management of a side game and the resulting penalty after a team has been disqualified has also caused a great deal of confusion with MNAs and domestic Controlling Bodies.

Concern has been around the severe penalty of forfeiting the game and clarity in the wording of the law itself. Recommendations have been received to reduce the severity of the forfeit to penalising with shot deductions. This approach would be inconsistent with any other law and was not felt to be a suitable solution. Penalties have always existed for the displacement of a bowl by its own team players but at the time of the 2021 Laws review these penalties were not felt to be severe enough for what is considered an act of "cheating".

Having considered several options to improve the intent of these two laws, the World Bowls Laws Advisory Group have concluded and recommended to the Board of World Bowls to rescind them. The numbering of Law 37.1.4 will remain untouched until the next review of the Laws.

The World Bowls Board, following recommendation from the World Bowls Laws Advisory Group, have agreed to rescind Laws 37.1.3 and 37.1.5.3 with immediate effect.
37.1.3 If a bowl in its original course is deliberately displaced or stopped by a member of the team that delivered the bowl, the defaulting team will forfeit the game to their opponent.
37.1.4 Displacement of a bowl in motion.
37.1.4.1 If a bowl in motion is displaced by a player and it has not disturbed the head after it is displaced, the opposing skip or the opponent in Singles must choose whether to:
37.1.4.1.1 place the bowl where the player believes it would have come to rest; or
37.1.4.1.2 declare the end dead.
37.1.4.2 If a bowl in motion is displaced by a player and it has disturbed the head after it is displaced, the opposing skip or the opponent in Singles must choose whether to:
37.1.4.2.1 place the bowl where the player believes it would have come to rest and replace any part of the head disturbed after the displacement; or

### 37.1.4.2.2 declare the end dead.

37.1.5 Displacement of a bowl at rest.
37.1.5.1 If a bowl at rest or a toucher in the ditch is displaced by a player and it has not disturbed the head after it is displaced, the opponent must put the bowl back to its former position.
37.1.5.2 If a bowl at rest or a toucher in the ditch is displaced by a player and it has disturbed the head after it is displaced, the opponent must put the bowl back to its former position and replace any part of the head disturbed after the displacement.
37.1.5.3 If a player lifts a bowl at rest on their rink to allow their team's bow in its original course to pass, the defaulting team will forfeit the game to their opponent.

## ASPECTS TO REIGN PLAYING PAIRS 1 - BE A VERSITILE LEAD - SHOTS \& STRATEGY

The key to a strong pair's partnership is vastly dependent on the ability of the lead, but not just for their traditional 'Lead' traits but for their ability to be versatile in their shot making ability. Tactically they must be astute and strong in their ability to read a head and select shots for their partner to play. These qualities are imperative as the lead will dictate strategy and shot making in most formats of pairs as the skip does not follow every bowl played to assess the situation and must rely on the leads decision-making.

## 2 - BOTH PLAYERS MUST CONTRIBUTE

Being portrayed as a unified partnership can be just as powerful against an opposition as having all the shot making ability in your locker. Approaching the game with similar tactics (ie. One player not being more aggressive in approach than the other) and showing unification can be disturbing to opposition and provide a positive energy between partners, leading to both players being more relaxed and playing to their highest ability possible. Both partners must have a mutual respect of each other and communicate clearly and openly. This communication in the form of small discussions, positive feedback, encouragement and collectively weighing up the risks and rewards of certain shots will ultimately be viewed as a strong pair to contend with.

## 3 - KNOW YOUR TEAM \& INDIVIDUAL STRENGTHS

Playing with the same pairs partner on a regular basis can pay off huge dividends when you find yourselves battling hard to play the winning shots. Having that intimate knowledge of each other's strengths and weaknesses can help to guide a strategy or tactic during a difficult game.

## FINAL END

A good pairs combination is not about the two best technical players playing together, but more so about two players combining with the same aspirations, attitude, style of play and versatility in playing a number of shots.

Working on other non-technical aspects of your game will certainly set you apart from the vast majority of lawn bowlers, hopefully developing your winning edge and ability to form winning partnerships.
